## Warranty & Policies & Customer Agreement

- Please do not ship your lower (the pistol grip) section which is an FFL item. Internal parts can remain if you cannot remove them yourself (we will remove prior to machining and re-install before returning to you unless otherwise requested).
- We must receive your slide within 2 weeks of placing your order to lock-in any special pricing quoted you.
- In the event your slide is damaged during custom work or if you are not absolutely blown-away with the work complete, DV8 Dynamics, Inc. will exchange your factory slide with our comparable custom billet slide cut design of the same size and model. We guarantee the quality of our custom billet slides to be that of factory or better.
- DV8 Dynamics cannot guarantee a set amount of time for custom work completion (lead-times can run up to 4 weeks not including Cerakote, but usually much less--please inquire current lead-times), however, we make every effort to complete your work order as soon as possible and will try to inform you if extended lead-time may occur. We perform work on a first-come, first-serve basis.
- You are aware and understand that any custom work performed on your slide may void your factory's warrantee.
- You understand that in order to achieve a certain cut design--any existing serial number(s) and/or factory lettering may be shaved off, cut over (eliminated). We make our best effort to smooth out any remnants of factory serrations/lettering by sometimes facing down a very small amount (usually less than 0.25mm) of material from the sides/top of your slide. If you wish to have your serial number re-engraved, please make a request in the comments above (+\$20 fee).
- **Cancellations:** If after we receive your slide and you decide to cancel, you must contact us before work begins. The handling fee is \$50.00 + \$25.00 return shipping.
- Please pack your slide well and double-check the address and be certain to include the suite during shipment to us. DV8 Dynamics, Inc. will not be held responsible for damage or missing components during shipment. We suggest you insure your package & add tracking, but not required.
